#### CWSF/WFLC 2016 Spring Meeting Recap

The 2016 Western Forestry Leadership Coalition (WFLC) Spring Meeting took place May 10-12 in Portland, OR at the Portland Marriott Downtown Waterfront. The theme of this year's meeting was Connecting People and Forests. On May 10, the Council of Western State Foresters (CWSF) met for a business meeting. The WFLC meeting kicked off with a welcome reception on May 10 where sponsors and WFLC attendees were able to network. May 11 began with welcoming remarks from Governor Brown's office followed by a presentation from Under Secretary Robert Bonnie. On the afternoon of May 11, attendees participated in a field tour to Tillamook Forest organized by Oregon state forester Doug Decker and Oregon Department of Forestry staff. The final day of the meeting featured two panels discussing partnerships to advance collective forestry visions in the Pacific Northwest and partnerships to advance regional and national shared forestry goals. In advance of WFLC federal members Capitol Hill meetings this spring and summer, CWSF policy and communications staff have been assisting Western Forest Service Regions by supplying talking points and informational materials on WFLC priority issues upon request.

CWSF staff participated at the Collaborative Restoration Workshop hosted by the National Forest Foundation, April 26 - April 27. The workshop acted as a forum for "sharing innovative approaches to collaborative restoration, tools, and lessons about planning, implementing, and monitoring restoration efforts on and around National Forest System lands." CWSF staff attended on behalf of the WFLC. Over 300 Forest Service, state agency, local, regional and national partners participated at the event.

## CWSF/WFLC Communications Highlights

The new CWSF logo and website launched in March. As a next step in the roll-out, CWSF recently became active on social media, utilizing LinkedIn and Twitter, @westernforester. CWSF began a monthly newsletter in April. This monthly newsletter will be sent out on the fourth Wednesday of each month and will be positioned as a CWSF focused newsletter with a WFLC section. Sara Goodwin, WFLC/CWSF Communications Director, is working with SE2, a local communications company, to refresh the WFLC website and logo. This work kicked off in early June and will wrap up in November.
