# 2025 ACCOMPLISHMENTS

- The FHC completed virtual meetings every other month, including three meetings with state-only members and three with state members and Forest Service partners.
- Continued efforts to expand the FHC membership in western states, U.S.-Affiliated Pacific Islands, and Forest Service regions.
- Crafted an FHC member survey in early 2025 to collect information about whether the FHC structure is
  meeting member needs and priorities, and ideas for improvement. The results came back favorably, indicating
  that FHC members find value in the committee, support its core information-sharing intent, and have a
  continued interest in maintaining the state and Forest Service nexus at every other meeting.
- Responded to the National Association of State Foresters (NASF) Forest Science & Health (FS&H) Committee
  information requests for national policy and/or programmatic interests, including critical invasive species
  across the West and western state forestry agency perspectives on FIA macro-plots.
- Made significant progress in building and maintaining a forest health resource library for the FHC to share
  materials, examples, and state approaches to topics/products such as Forest Health Highlights reports, State
  Fact Sheets, NASF forest health reporting, and more.
- Conducted information and data gathering within FHC member states to craft the first <u>Forest Health Highlights</u>
   <u>& Accomplishments Report.</u>
- Completed two standalone virtual meetings to examine forest health metrics across western state forestry agencies, explore ideas to standardize metrics and identify best practices, and determine outstanding

- questions linked to NASF forest health accomplishments reporting.
- Hosted a two-day virtual 2025 Annual Meeting on September 30 and October 1, 2025. Attendees included FHC representatives from 13 western states, seven Forest Service Forest Health Management (FHM) staff, and partners such as NASF FS&H Committee staff. Meeting topics included the future of forest health aerial surveys, Forest Service Washington Office FHM updates, NASF FS&H updates, forest health monitoring and the 2025 Conditions Report, and more.

- Develop one to two whitepapers in response to identified FHC priorities intended to enhance and further state
  and Forest Service forest health programs, such as the value of continued aerial surveys for state and federal
  agencies.
- Continue efforts to examine forest health reporting metrics across western state forestry agencies and explore opportunities to standardize metrics and establish best practices.
- Maintain an updated FHC resources library on the CWSF Google Drive, and explore opportunities to continue sharing resources in response to new and emerging priorities.
- Update the Forest Health Highlights & Accomplishments Report, craft two to three success stories to accompany the report, and explore opportunities to strengthen the content and messages within the report.
- Where opportunities arise, invite forest health subject matter experts from state forestry, the Forest Service, tribes, state agriculture agencies, and other partners to FHC meetings.
