SUBJECT: FY 2023 Western States' State Fire Assistance WUI Competitive Grant Recommendations

**DATE:** March 16, 2023

The Council of Western State Foresters (CWSF) requests that the USDA Forest Service (USFS) State and Private Forestry disburse Fiscal Year 2023 National Fire Plan (NFP) State Fire Assistance (SFA) competitive funding to the western states according to the enclosed table.

The Western State Fire Managers' (WSFM) Wildland Urban Interface Grant Committee met in-person in Denver, CO during the month of January 2023, prior to initiation of the grant review period. 64 eligible grant applications submitted by 11 western states/islands and requesting a total of \$18,196,271 were received, reviewed, scored, and prioritized by the Committee. The enclosed table reflects the distribution of \$13,421,620 towards 47 grants. The CWSF Executive Committee discussed and unanimously approved the western recommendations at the \$13,421,620 funding.

Many successful applications will go unfunded. The rigorous process established in the west to review, rank, and select applications allows any additional funds from your office to be distributed to the next application(s) in queue; the CWSF respectfully requests such distribution of additional funds should they become available.
